NOTICE TO BIDDERS

Town of North Andover, Massachusetts ROAD AND SIDEWALK RESTORATION – GAS EXPLOSION IMPACT AREA – CONTRACT 3, 4, & 5

The Town of North Andover invites sealed bids for the "Town of North Andover, Massachusetts, "**Road and Sidewalk Restoration** – **Gas Explosion Impact Area** – **Contract 3, 4, & 5**", in accordance with the Contract Documents prepared by Environmental Partners Group, 1900 Crown Colony Drive, Suite 402, Ouincy, Massachusetts, 02169.

Electronic bid proposals for the project will be received through the Internet using ProjectDog until the date and time stated below and will be posted on www.projectdog.com forthwith after the bid submission deadline. Paper copies of bids will NOT be accepted.

Bid deadline: THURSDAY, APRIL 27, 2023 AT 10:00 A.M.

The location, general characteristics, and principal details of the Work are indicated in a set of drawings, entitled "Town of North Andover, Massachusetts, Division of Public Works, Road and Sidewalk Restoration – Gas Explosion Impact Area – Contract 3, 4, & 5."

The work to be done under this contract shall be in accordance with these specifications and referenced standards and includes roadway and sidewalk rehabilitation along select roadways town-wide, including pavement milling and hot mix asphalt overlay, hot mix asphalt overlay without milling, full-depth patching, removing and resetting existing granite curbing or edging, installing hot mix asphalt curb or berm, installing new granite curbing or edging, reconstructing hot mix asphalt and cement concrete sidewalks, constructing driveway aprons and pedestrian curb ramps conforming to ADA/AAB requirements, minor drainage and sanitary sewer structure alterations, including adjusting drainage and sanitary structures, replacing or installing new catch basins and manholes as directed, tree removal and trimming, fence removing, resetting, and replacing, loam and seed, pavement markings, safety controls and signage for construction operations, and all other incidental items. All work shall be performed in accordance with these specifications and completed within the identified bid items.

The roadways/sidewalks anticipated to be included in the subject project, the limits of construction, and the type of construction have been illustrated in the plans for bidding purposes only; the actual construction and construction limits shall be at the discretion of the Town and is subject to change from that illustrated. Varying level of detail is provided for each roadway depending on anticipated construction.

- Much of the work included in this project is anticipated to be performed as a "book job" based on these specifications, the provided details, the provided key plan/location map, referenced standards, and the on-site direction of a representative of the Town.
- Detailed design plans are provided for implementation along Saltonstall Road, where changes to the roadway geometry are being proposed.

The Town of North Andover reserves the right to change, modify, increase or decrease the limits of work, add or remove any of the streets listed in this contract, and change the method of rehabilitation of roadway

and/or sidewalk at its discretion. The Town also reserves the right to increase or decrease quantities of items without renegotiation of unit prices.

The Contractor shall work continuously on the project until all work included in the contract is complete.

The successful bidder will commence the work required by the contract documents by the date specified in written notice to proceed. It is anticipated that the work to be done under this contract shall be completed by May 31, 2024, but a contract extension shall be at the discretion of the Town.

Prospective Bidders shall be prequalified in accordance with 720 CMR 5.00 at the time of the bid opening. The MassDOT Prequalification Office will provide the Town with an official contractor list and a waiver contractor list for all contractors prequalified in the specified class of work within the parameters of this project. Only those bidders listed in the official or waiver contractor list issued by the MassDOT Prequalification Office will be allowed to submit a bid and receive an award of contract.

Hard copies of addenda will not be mailed or faxed. It shall be the sole responsibility of the Contractor to ascertain the existence of any and all addenda, whether or not the addenda are presented, or received by the Bidder.

A complete set of Bidding Documents shall be used in preparing Bids; neither the Owner nor Engineer assumes any responsibility for errors or misinterpretations resulting from the use of the incomplete sets of Bidding Documents or for modifications to the Bidding Documents, including electronic conversion.

Bid Security in the sum of five (5) percent of the Total Bid is required. The Bid Security in the form of a Bid Bond shall be with a surety company qualified to do business in the Commonwealth of Massachusetts and satisfactory to the Owner and submitted with your E-Bid online at www.Projectdog.com. Bid Security in the form of cash or a certified check, treasurer's or cashier's check issued by a responsible bank or trust company and made payable to the Owner must be submitted with a completed Cash Bid Bond Affidavit form and received by the Owner before the bid opening for the bid to be valid. These shall be submitted to the Town of North Andover Division of Public Works, 384 Osgood Street, North Andover, Massachusetts, 01845 before 10:00 AM Thursday, April 27, 2023.
